I am responding to your letter dated July 20, 2021, regarding the Review Report 21-202-RR on a request for access review of file 21-145. In the Review Report 21-202-RR, you provided three (3) recommendations to the Department of Education. Please find my responses to your referenced recommendations below.

1. I recommend that the Department of Education review its ATIPP processing procedures and staffing to ensure that they are adequate to ensure statutory deadlines are routinely met and that extensions are required only in unusual circumstances.

The Department of Education will work with the ATIPP Territorial Manager to review staffing and ATIPP processing procedures. This will provide the department an opportunity to remedy any processing issues and ensure that statutory deadlines be routinely met.

2. I recommend that the Department of Education work with the Applicant to see if the request can be refined.

The Department of Education contacted the Applicant on July 15, 2021, by teleconference and refined the information request. On July 16, 2021, an email from the Manager of Policy was sent to IDEA reiterating the details of the information request as agreed on during the teleconference.
